The Limited Warranty is issued to YOU only by Prime Auto USA, LLC It applies only to the motor VEHICLE described above. It cannot be transferred to any other person.

SECTION 3 – COVERAGE

THE FOLLOWING ARE COVERED:

1. Who is covered by the Limited Warranty? Prime Auto USA, LLC offers the Limited Warranty to you, the Customer(s) listed above and it cannot be transferred to any other person. Only you and any person who is entitled under applicable state law may enforce the obligations of this Limited Warranty. In addition, to be eligible for the Limited Warranty, your vehicle must be purchased and used for personal family and household purposes.
2. What is covered under this Limited Warranty? Subject to your written authorization and to the provisions of the Limited Warranty, for the duration of the Limited Warranty, Prime Auto USA, LLC will pay 100% of the total cost of the parts and labor necessary to repair or replace the Covered Items listed below. If the defect or malfunction of the Covered Part(s) is caused by a mechanical breakdown or failure under normal service (the inability of any covered part to perform its designed function).

Transmission

At its sole discretion, Prime Auto USA, LLC or its vendors may use used or remanufactured parts. The timeliness of the service or repair may be affected by the availability of replacement parts. Upon re-delivery of the vehicle, you must pay for any expenses, plus applicable taxes, that TPrime Auto USA, LLC is not obligated to provide or pay for under the Limited Warranty.

3. How do you make a warranty claim? During the term of this Limited Warranty, you must notify Prime Auto USA, LLC at the telephone number listed above, or in person, of any failure or malfunction of a covered item. You must then deliver the vehicle to TPrime Auto USA, LLC or a vendor Prime Auto USA, LLC selects for you within 15 days of your notice to Prime Auto USA, LLC, unless Prime Auto USA, LLC agrees otherwise. You must authorize in writing, all repair work to be performed under this Limited Warranty. Prime Auto USA, LLC will not reimburse you for any covered services or repairs that are not performed by Prime Auto USA, LLC, unless you receive advance written authorization to have the services/repairs performed elsewhere and are able to provide Prime Auto USA, LLC with written receipts. Prime Auto USA, LLC reserves the right to inspect the vehicle both prior to and after a service/repair as performed pursuant to a claim under this Limited Warranty.

4. What is NOT covered? The following are NOT covered under this Limited Warranty.
- Any item not listed under: "What is Covered?" or which is covered by a manufacturer's warranty, recall program, or factory service bulletin or an insurance policy.
 - Any defect or malfunction resulting from any of the following: The failure to perform maintenance in accordance with the manufacturer's recommendations; the lack of appropriate fluid levels (e.g. oil, water, transmission fluid), continued operation of the vehicle after the occurrence of a mechanical breakdown or warning light notice; the failure of a non-covered part; modification of the vehicle from or operation of the vehicle in a manner that is not in conformance with the manufacturer's specifications or intended use; as accident or collision, improper or containment fuel, misuse, abuse, tampering, negligence, theft, vandalism or act of nature or God.
 - Any vehicle purchased and/or used for purposes such as towing, taxi or limousine service, deliver, hire, on- or off-road competition, or engaging in a contest of speed or endurance of any type.
 - Any diagnosis and/or repairs performed prior to obtaining prior authorization from Prime Auto USA, LLC.
 - Towing costs, storage costs, and maintenance services and parts which include, but are not limited to; alignments, adjustments, wheel balance, tune-ups, spark plugs, spark plug wires, hose, drive belts, shop supplies and hazardous waste.
 - Any repair or replacement of a covered item if a breakdown has not occurred.

- There are no warranties which extend beyond the description herein. We are not liable or responsible for any incidental, consequential, commercial, or exemplary losses or damages. Some states do not allow limitations on implied warranties or the exclusion of incidental or consequential damages, so these limitations may not apply to you.
- This Limited Warranty gives you specific legal rights, but you may also have other rights depending upon the state in which you purchased the vehicle.
- You should read the Limited Warranty carefully. It contains all of the information regarding coverage under the Limited Warranty. There is no other agreement between you and Prime Auto USA, LLC regarding warranty coverage.
- None of our representatives, employees, or other agents are authorized to alter, extend, amend or modify the terms of this Limited Warranty.
- ALL REPAIRS WILL BE LIMITED TO \$3,500 PER VEHICLE FOR THE DURATION OF THE CONTRACT.
- Loaner vehicles may not be provided, and you may be responsible for your own transportation while your vehicle is being serviced.
